ADDENDUM NO. 5

Date Issued: March 5, 2019

Bidders on this project are hereby notified that Addendum No. 5 shall be attached to and made part of the above-named Bid Documents, dated February 2019.

The following items are issued to add to, modify, and clarify the Bid Documents. These items shall have full force and effect as the Bid Documents, and the cost involved shall be included in the various prices bid. Bids, to be submitted on the specified date, shall conform to the additions and revisions listed herein.

1. The due date and time for submitting bids are unchanged – March 21, 2019 at 2 PM EST.

2. Question # 1 received as follows:

“In the Statement of Contractor’s Qualification, #g in Company History, it states that we need to have Completed at least Five (5) Projects within the past Ten (10) Years, with a Minimum of \$1M or greater Contract Price. It also states to Provide that information in the Experience Record Section ...

However, on the Experience Record Section, it states that you only want Three (3) Projects within the past Ten (10) Years, with a Minimum of \$1M or greater Contract Price ...

So, do we need Three (3) or Five (5) References for the Experience Portion of this bid mentioned above?”

Answer to Question # 1: Bidder is given the opportunity on page 1 of the Statement of Contractor Qualifications / Questionnaire to affirm that they have completed five (5) such projects as described. Bidder is then given the opportunity on page 2 of the same form to provide at least three (3) references for such projects.

3. Question # 2 received as follows:

My Insurance person is wondering about your Insurance Requirements, for the bid mentioned above ...

“Well this seems excessive. For GL they want \$2m occurrence/\$5m aggregate and they want umbrella with \$10m occurrence/\$10m aggregate....so \$12m occurrence total and \$15m aggregate total. We have \$6m occurrence/\$7m aggregate currently” ...

I am curious on Why so excessive on the Coverage for an Estimated Project Value of \$ 4,145,000.00? ...

Can these Limits be Lowered to a Figure that is in Line with the Estimated Project Value? ... If they cannot

1 be Lowered, please Explain in great detail, why not ...

3 **Answer to Question # 2:** The insurance requirements for the project were selected to ensure that the
4 Authority is adequately protected against any and all claims that could result from this project and the
5 limits will remain as stated in item 18 of the Supplementary Conditions.

7 Pursuant to Bid Form, Article 2.1, all Bidders who submit a bid are accepting all of the terms and
8 conditions of the Invitation to Bid and the Instructions to Bidders. This Article states that Bidder shall
9 provide to the Owner proper Certificates of Insurance meeting the terms of the Agreement within five (5)
10 days of Notice of Award. Bidders who cannot meet the Insurance requirements within the time
11 constraints given should understand that if a proper Certificate of Insurance is not received within five (5)
12 days of the Notice of Award, that the Owner reserves the right to reject the bid and award the project to
13 the next lowest, responsible and responsive Bidder.
